The Eastern Regional Committee in its 177th meeting held on 18th November 2014 after considering the representation received from the State Govt. of Odisha and made the following observations:-

"The Commissioner-cum-Secretary to Govt., Government of Odisha, School and Mass Education Department has submitted a notification vide letter dated 27th September 2014 has informed the following as under:

"... to ensure access to good quality teacher education facilities for rural and remote areas and facilitate the entry of talented persons particularly persons from SC, ST and Minority concentration areas into the teaching profession, the State Govt. have now decided to establish following 04 Block Institute of Education and Training (BITE) by upgrading the existing Teacher Training Institutions.


1.	Govt. S.T. School, Grumahisani	Block Institute of Education & Training, Gorumahisani, Mayurbhanj.
