

Course of two year duration under Section 15 of the NCTE Act, 1993 on 14.07.2013 and hard copy received at ERC, NCTE on 23.07.2013.

2. AND WHEREAS, the Eastern Regional Committee in its 163rd meeting held on 29th - 30th October 2013, after considering the records available in the file and relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE Hqrs., the Committee discussed the matter in detail and decided as under:-

- (i) The institution is recognized for C.T course (file No.OR-E/E-60/96) with an annual intake of 50 from the academic session 2001-2002.
 - (ii) The institution granted permission for additional intake of D.El.Ed. Course (Code No.ERCAPP745) with an additional annual intake of 50, thus making the total annual intake of 100 from the academic session 2012-2013.
 - (iii) Further, the institution applied for D.El.Ed. Additional intake on 14.07.2013.
 - (iv) The gap of three academic years is not completed.
 - (v) As per request of the State Representative, one month time is given for getting the relaxation from the NCTE Hqrs. for relaxation of gap of 3 academic years.

In view of the above, the committee decided as under: Wait for one month.

3. AND WHEREAS the similar cases were placed in 162nd ERC Meeting. As per the decision of 162nd Meeting, one month time was allowed for getting relaxation of gap of 3 academic years from the NCTE Hqrs.

4. AND WHEREAS the State Government has not submitted any reply / comments to ERC, NCTE in response to the decision of 162nd & 163rd Meeting. The original file of the institution along with other documents were considered by the ERC in its 164th meeting held on 21-22 November 2013, which observed as under :-

"The stipulate period of one month time has already been lapsed and reply / comments not received from the State Government for getting relaxation of gap of 3 academic years from the NCTE Hqrs.

In view of the above, the committee decided to refuse the application of the intuition for the applied course D.El.Ed (Additional Intake) under section 15(3)(b) of NCTE Act 1993".

NOW, THEREFORE, grant of permission to District Institution of Education and Training, Mayurbhanj, Plot No. - 262, Vill - Murgabadi, PO - Bhanjpur, Tehsil/Taluka - Baripada, Town/City - Baripada, Dist - Mayurbhanj, Odisha - 757002 (Code No. ERCAPP1871) for D.El.Ed.(Additional Intake) course is terms of section 15(3)(b) of NCTE Act, 1993, is hereby refused.

- Educational & Professional qualification certificates of all teaching staff showing their eligibility for appointment as per the NCTE norms and experience certificate of the Principal/HOD.
- Account opening form duly filled in for conversion of FDRs into joint account or document establishing that the FDR of Endowment Fund and Reserve Fund have been converted into a joint account. In case It is self-financed institution.
- An undertaking from the Management of the institution as per the prescribed format available on ERC Website.
