WHEREAS in terms of Section 15(1) of the NCTE Act, 1993, District Institute of Education & Training, Nayagarh, Rajsunakhala, Plot No. - 181, 182, 183, 184, 186, VIII - Rajsunakhala, PO - Rajsunakhala, Tehsil/Taluka - Ranpur, Town/City - Rajsunakhala, Dist - Nayagarh, Odisha - 752065 has submitted an application (Code No. ERCAPP1872) to the Eastern Regional Committee of NCTE for grant of permission for conducting D.El.Ed Course (Additional Intake) with an additional annual intake of 50 (fifty) by online on (mm/dd/yyyy) 7/14/2013 and hard copy of application submitted on (mm/dd/yyyy) 7/22/2013.

2. AND WHEREAS the NCTE Hqs. vide letter No.A78554, dated 3.12.2013 granted relaxation for increase of intake capacity in the existing teacher training institutions in the State of Odisha with following observation and direction.

... An assurance/undertaking has been given by the Government of Odisha, to the NCTE accordingly, that they will fulfill all the criteria, procedural as well as infrastructural, for the teacher education institutions in the State by December, 2014. The Commissioner-cum-Secretary to the Government of Odisha vide her letter No.25410/SME dated 05.11.2013 has conveyed that to make good the deficiencies in the staff position, 65 teacher educators have been appointed in different teacher training institutions on a regular basis. Furthermore, 116 more teacher educators under in-service quota have been selected and in a very short time they will be posted. Besides this the process of filling up other vacant posts will be made within March, 2014.

In view of the above, it has been decided, as a one time measure to relax the procedural and infrastructural requirements for the Teacher Education Programmes, proposed to be set up/run by the Government of Odisha. During this period, the Regional Director, ERC would take a view of the shortcomings and convey the same to the State Government of Odisha, NCTE and the Govt. of India for necessary action at their end to fulfill the requirements under the NCTE Rules and Regulations. The procedural and the staff requirements will be complied with by the Government of Odisha in a period of 4-6 weeks of the communication by NCTE. The infrastructural requirements would be fulfilled by December, 2014; the State Government shall however, make adequate infrastructural arrangements on lease/rental basis as per the stipulations of NCTE, before approval.

Accordingly, the procedure for processing the request of the Government of Odisha would be initiated; the formal letter of approval would however, be issued subject to the following to conditions:

- (i) All staff as per the norms and standards of NCTE is in place by February 2014.
- (ii) There is an adequate budgetary allocation in the budget of the State Government for the year 2014-15, for provision of requisite infrastructure as per the norms and standards of NCTE.

NCTE Headquarters would keep a watch on the situation and keep Government of Odisha and MHRD apprised of the shortcomings so that the same can be fulfilled expeditiously, within the period of relaxation. In case, at the end of December, 2014 all the criteria, as per the rules and regulations of the NCTE are not fulfilled, NCTE would be at liberty to withdraw the recognition given to the respective teacher education institutions recommended by the Government of Odisha.

Keeping in the above in view the Eastern Regional Office shall process the applications of the 71 Teacher Education Institutions referred by the State Government and dispose the same expeditiously as per NCTE Act, Rules and Regulations.

3. AND WHEREAS the ERC, NCTE as per the decision of 166th meeting held on 19th - 20th December 2013 communicated to the Commissioner-Cum-Secretary, Department of School and Mass Education, Govt. of Odisha to comply the following requirement.

- (a) List of the faculty for each institution duly countersigned by the Director T.E. & SCERT.
- (b) Status of budgetary allocation of the State Govt. for the year 2014-2015 for provision of requisite infrastructure for all institutions as per the Norms and Standards of NCTE.

4. AND WHEREAS as the Commissioner-Cum-Secretary, School & Mass Education Department, Govt. of Odisha vide letter No.2476 dated 06.02.2014 as well as the Director T.E & SCERT, Odisha, Bhubaneswar vide letter No.809 dated 11.02.2014 intimated the initiative taken by the Govt. of Odisha as given under.

- (1) Against the vacant posts ninety five Teacher Educators have been appointed in different DIETs/DRCs and 116 Teacher Educators have been selected but due to court case, the process of appointment has been delayed, very soon they will be posted.
- (2) A budget provision of Rs.30 Crores have been made by the State Government to make good the deficiencies in infrastructure.
- (3) The Department has prepared road map to complete the work within the stipulated time by proposing the project to Expenditure Finance Committee (EFC).
- (4) Amount required for completion of the incomplete building works of DIETs and DRCs under CSP shall borne by the State Govt.
- (5) The Government is also taking responsibility to provide all other facilities whichever will be required as per Rules and Regulations of NCTE.



With a condition that the deficiencies being communicated after the inspection of the institution to be complied within stipulated period stated in the relaxation order of NCTE Hqs.

As per the decision of 163rd ERC Meeting VT was constituted and inspection had been conducted on 21.02.2014.

As per Visiting Team Report, the following deficiencies are found:-


- (i) Library is running without a permanent librarian. Catalogue systems are yet to be introduced. Reference reading facility is very poor. Research journals are limited in number. Reference books on education in English are inadequate.
- (ii) The number of faculty required for increasing additional intake is absent. Many teaching and non-teaching posts which are in existence are vacant.

Callalant

- (iii) Though initiation of infrastructural development is about to start, the physical condition of class rooms are very poor and even unsafe for the students.
- (iv) As per essential data sheet, the built up area in the building is 1472.296 Sq. Mts. which is less than the required 2000 Sq. Mts. for additional intake of existing D.El.Ed. Course, as per NCTE norms.
- (v) As per essential data sheet, the size of multipurpose hall is 556.7 sq. ft. which is less than the required 2000 Sq. ft. as per NCTE norms.

In view of the above you are therefore requested to fulfil the above deficiencies within the relaxation period and communicate the same with all supporting documents to the ERC, NCTE. In case at the end of December 2014 all the criteria as per the Rules and Regulation of NCTE are not fulfilled, NCTE would be at liberty to withdraw the recognition given to the institution.



Sir/Madam,

The Eastern Regional Committee in its 179th meeting held on 22nd -23rd January 2015 considered the matter of the said institution and made the following observation:

"The institution District Institute of Education & Training, Nayagarh, Rajsunakhala, Plot No.- 181, 182, 183, 184, 186, VIII/PO - Rajsunakhala, Tehsil/Taluka - Ranpur, Town/City - Rajsunakhala, Dist - Nayagarh, Odisha - 752065 (Code No. ERCAPP1872) was granted permission for conducting D.El.Ed course with an additional intake of 50, thus making the total annual intake of 100 students vide this Order No. 24228 dated 24.02.2014 from the academic session 2014-2015 subject to fulfilling the following conditions :-

1. All staff as per the norms and standards of NCTE is in place by February 2014.
2. There is an adequate budgetary allocation in the budget of the State Government for the year 2014-15, for provision of requisite infrastructure as per the norms and standards of NCTE.

As per 177th ERC meeting held on 18th November 2014 ERC, a Show Cause Notice to the institution was issued on 24.11.2014 on the following grounds:-

1. The institution is required to submit a fresh blue print of building plan duly approved by a Govt. Engineer.
2. The institution is required to submit building completion certificate issued by a Govt. Engineer.
3. The institution is required to submit a fresh faculty list in the prescribed proforma duly approved by the competent authority alongwith their educational/ professional certificates.

The institution submitted the written representation dated 29.12.2014. The committee considered the representation of the institution and observed that the institution is still deficient on the above points.


In view of the above, the committee decided as under:

Show Cause notice be issued to the institution as to why the recognition to the institution be not refused on the above points. The Committee therefore, provides an opportunity under section 15(3)(b) of the NCTE Act 1993 to the institution to submit its reply within 21 days from the issue of the letter before the Committee takes final decision.

A copy of this letter may be endorsed to the Secretary, School and Mass Education as well as Director SCERT for information with a request to submit a consolidated compliance report of all the institutions granted recognition/permission as per the relaxation given by NCTE on or before 31st December 2014.

2. In view of the above decision of ERC, you are hereby required to submit the above details/ clarification as applicable along with all necessary documents to ERC, NCTE within 21 days.
3. In the event of this office not receiving any representation within 21 days of the issue of this letter, it will be presumed that you do not wish to make any representation and the Eastern Regional Committee shall take the decision, as it deems fit and proper. However, if the institution has already submitted the reply in response to uploaded minutes of 179th meeting of ERC in its website, the same shall be treated as the reply to the decision of ERC.
