2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Elementary Teacher Education (D.El.Ed) programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

4. NOW, THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants permission to for conducting D.El.Ed. Course of Elementary (level) of two year duration with an additional annual intake of 50 (fifty), thus making the total annual intake of 100 (one hundred) from the academic session 2014-2015 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009.

4. The recognition/permission is subject to fulfillment of the following:

- (i) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

In terms of Section 14(1) of the NCTE Act, 1993 Govt. Secondary Training School, Chikiti, Ganjam, Orissa had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting Teachers' Certificate Course of Two years duration from the academic session 2003-2004 with an annual intake of 50 (Fifty) students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- The institution has acquired the land for setting up the teacher education institution.
- The institution has constructed the building for conducting the course.
- The institution has selected four regular teachers and one Hindi teacher for the said course and the list of faculty members has also been approved by the SCERT.

3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to Govt. Secondary Training School, Chikiti, Ganjam, Orissa for Teachers' Certificate Course of Two years duration from the academic session 2003-2004 with an intake of 50 (Fifty) students, subject to fulfillment of the following:

- That the institution will ensure that Headmaster and at least five regular faculty members duly approved by the SCERT are in position for an intake of 50 students before commencement of the course and a report to this effect shall be sent to the ERC within one month of commencement of the course.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by the State Govt.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the SCERT to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.


