

A copy of NCTE Act, Rules & Regulations and norms & Standards thereof are also available on the NCTE website www.ncte-india.org and also in the ERC website www.ercncte.org.

2. You are therefore, now requested to be ready with the various infrastructural and instructional facilities as per the Norms and Standards 2009 prescribed by the NCTE. Inspection shall be caused on any day within 20 days from the date of this communication.

3. Visiting Team shall verify the infrastructural and instructional facilities available in your institution for the proposed/existing **D.El.Ed course (Additional Intake)**. It is requested that originals of all the documents required under the relevant provisions of the NCTE Act, Rules and Regulations should be kept ready and made available to the Visiting Team during the time of inspection for verification of the same. The copies of the documents may also be handed over to the Visiting Team.

4. The institution shall be required to provide the building completion certificate as per the specified format (format enclosed) indicating that the building has been constructed as per approved building plan, the total land area (including khasra no. etc.) and the built up area thereon, at the time of inspection, along with the building completion certificate issued by the competent civil authority, if not submitted earlier. The videography of the institution needs to be done as per provisions in Regulation 7(5) of the NCTE Regulations 2009. The inspection will not be carried out if arrangements for videography are not made.


Video recordings should be submitted to the Visiting team on the spot immediately just after the inspection is completed. The institute shall make arrangements for videography at their own risk.

Subject: Clarification and willingness for compliance of the NCTE (Recognition Norms and Procedure) Regulations, 2014 and its implementation by all the existing Teacher Training Institutions.

Dear Sir/Madam,

You are aware that NCTE has notified National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2014 vide Notification No.346 dated 01.12.2014. The Regulations have come into force w.e.f. the date of publication in the Gazette of India and with the publication of the NCTE Regulations, 2014, the Regulations of 2009 stands repealed. The New Regulations are applicable in respect of both existing Teacher Education Institutions and the new institutions intending to offer Teacher Education Programme(s). The Regulations have introduced some new provisions and have modified some of the provisions in the Regulations which were in force since 2009. The existing Teacher Education Institutions (TEIs) shall have to initiate appropriate action to adhere to the New Regulations, Norms and Standards for various Teacher Education Programmes. An Explanatory Note on implications of the New Regulations for the existing Teacher Education Institutions is attached herewith for your reference. You are advised to take the required action at the earliest and intimate the same to the undersigned within 21 days from the date of receipt of this letter along with the affidavit in the prescribed format, failing which the revised order of recognition will not be issued and the recognition granted earlier will become invalid.

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993, Govt. Secondary Training School, Sakhigopal, Plot No- 717, Street No.- Sakhigopal, Vill - Sakhigopal, PO - Sakhigopal, Tehsil/Taluka - Sathyabadi, Town/City - Sakhigopal, Dist - Puri, Odisha - 752014 has submitted an application (Code No. ERCAPP1919) to the Eastern Regional Committee of NCTE for grant of permission for conducting D.El.Ed Course (Additional Intake) with an additional annual intake of 50 (fifty) by online on (mm/dd/yyyy) 7/20/2013 and hard copy of application submitted on (mm/dd/yyyy) 7/24/2013.

2. AND WHEREAS the NCTE Hqrs. vide letter No.A78554, dated:3.12.2013 granted relaxation for increase of intake capacity in the existing teacher training institutions in the State of Odisha with following observation and direction.

... An assurance/undertaking has been given by the Government of Odisha, to the NCTE accordingly, that they will fulfill all the criteria, procedural as well as infrastructural, for the teacher education institutions in the State by December, 2014. The Commissioner-cum-Secretary to the Government of Odisha vide her letter No.25410/SME dated 05.11.2013 has conveyed that to make good the deficiencies in the staff position, 65 teacher educators have been appointed in different teacher training institutions on a regular basis. Furthermore, 116 more teacher educators under in-service quota have been selected and in a very short time they will be posted. Besides this the process of filling up other vacant posts will be made within March, 2014.

In view of the above, it has been decided, as a one time measure to relax the procedural and infrastructural requirements for the Teacher Education Programmes, proposed to be set up/run by the Government of Odisha. During this period, the Regional Director, ERC would take a view of the shortcomings and convey the same to the State Government of Odisha, NCTE and the Govt. of India for necessary action at their end to fulfill the requirements under the NCTE Rules and Regulations. The procedural and the staff requirements will be complied with by the Government of Odisha in a period of 4-6 weeks of the communication by NCTE. The infrastructural requirements would be fulfilled by December, 2014; the State Government shall however, make adequate infrastructural arrangements on lease/rental basis as per the stipulations of NCTE, before approval.

Accordingly, the procedure for processing the request of the Government of Odisha would be initiated; the formal letter of approval would however, be issued subject to the following to conditions:

- (i) All staff as per the norms and standards of NCTE is in place by February 2014.
- (ii) There is an adequate budgetary allocation in the budget of the State Government for the year 2014-15, for provision of requisite infrastructure as per the norms and standards of NCTE.


