



WHEREAS, In exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. **AND WHEREAS**, the institution viz. Hindi Teacher's Training Institute, Block No.-29, Old Secretariate, Dist.-Cuttack, Orissa-753001 was granted recognition for conduct of B.H.Ed. Course of One year duration with an annual intake of 100 vide ERC order No. ERC/7-78.6(I).7/2007/69201 dated 06.08.2007.

3. **AND WHEREAS**, the institution viz. Hindi Teacher's Training Institute, Block No.-29, Old Secretariate, Dist.-Cuttack, Orissa-753001 has by affidavit dated 31.03.2015 consented to come under New Regulations 2014 and sought for **Two Basic Units in B.H.Ed. course**, which require additional facilities.

4. **AND WHEREAS**, it has been decided to permit the institution to have two basic units of 50 students each with subject to fulfill following conditions namely,

- (i) The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committee with required documents by October 31, 2015.
- (ii) The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.

- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

5. Now therefore, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Eastern Regional Committee, NCTE hereby grants recognition to **Hindi Teacher's Training Institute, Block No.-29, Old Secretariate, Dist.-Cuttack, Orissa-753001** for conducting B.H.Ed. 

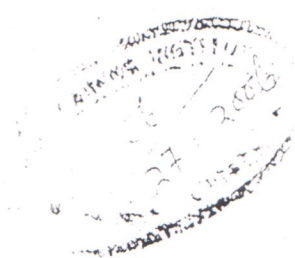

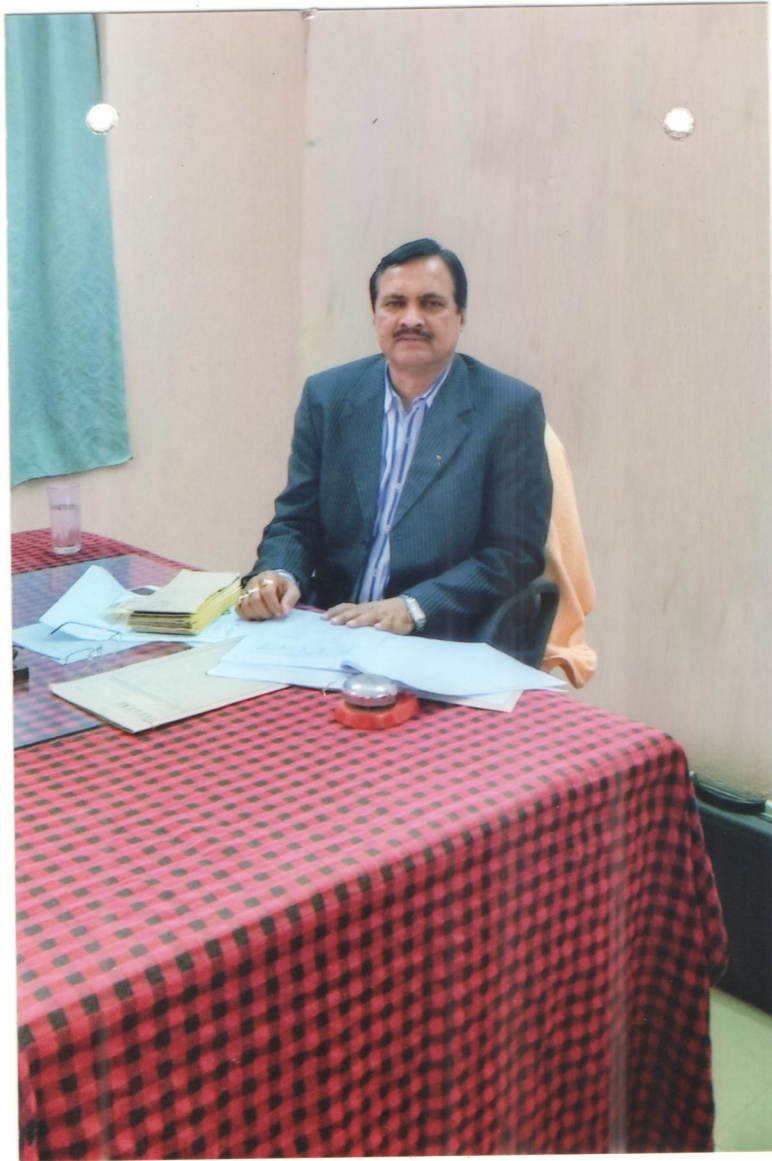

Sub : Strengthening the study of Hindi as the National Language in schools.


In consideration of the decision taken in the High Level Meeting chaired by J.C.-cum-Addl. Chief Secretary on 6th September 2005 and 1st Apr. 2006 Govt. have been pleased to revive the erstwhile Hindi Training Institute, Cuttack with the following conditions

1. The nomenclature of the institution shall be "Hindi Teachers Training Institute" instead of "Hindi Training Institute".
2. The institute shall function in the premises of the erstwhile Hindi Training Institute utilising the existing infrastructure and other support system.
3. The Institute shall offer one year in-service training in Hindi with an intake of 100 with approval of Eastern Regional Council, NCTE.
4. The in-service teachers shall be selected on the basis of their service seniority i.e. as per their date of joining.
5. The institute shall also conduct short term inservice training programmes ranging from 05 to 10 days for practising Hindi Teachers of High Schools.
6. Three Class-II Officers earlier working as Principals in three erstwhile Hindi Training Institutions, five lecturers (Non-Gazetted), two Hindi Teachers (Class-III / Non-Gazetted), six Class-III employees and five Class-IV employees out of 16 shall be deployed to work in the Institute. Their salaries shall be drawn from the establishment of DIETs they are at present placed at.
7. The senior most Class-II Officer out of the three erstwhile Principals shall be designated as Principal. He / She shall be entitled to draw his / her salary in his/her own scale of pay. He / She shall not be entitled to any additional allowance.

8. The establishment related expenditure of the newly established HTTI shall be met from the fees to be collected from the students to be enrolled in the course. The expenditure on short term orientation programme shall be met from the Govt. of India funds. No expenditure shall be charged on the Govt. exchequer.
9. The principal shall submit a proposal through Director, TE & SCERT for sanction of funds for furniture and other infrastructure limiting to an amount of Rs.50, 000/-.
10. The institute shall be affiliated to the Board of Secondary Education, Orissa for awarding certificate to successful candidates.
11. After the present course is put in place, separate attempt shall be made by the Principal of the Institute to start one year pre service Hindi Teacher Training Course equivalent to B.Ed degree with necessary affiliation to Utkal University.




