OR

Higher Secondary (or its equivalent) with at least 50% of marks and 2-year Diploma in Education (Special Education).

Graduation and two year Diploma in Elementary Education (by whatever name known)

AND

- (b) Pass in the Odisha Teacher Eligibility Test (OTET-Category-I)
- (c) Candidates must have Odia as MIL up to Class-X or pass in Odia language test equivalent to Matric standards conducted or declared equivalent by Board of Secondary Education, Odisha except the candidates as mentioned under Para.6.2.

Category-2

(a) Graduation and 2-year Diploma in Elementary Education (by whatever name known).

OR

Graduation with at least 50 % marks and 1-year Bachelor in Education (B.Ed)

OR

Graduation with at least 45% of marks and 01-year Bachelor in Education (B.Ed.) in accordance with NCTE (Recognition Norms and Procedure) Regulations issued from time to time in this regard.

Higher Secondary (or its equivalent) with at least 50% of marks and 4-year Bachelor in Elementary Education (B.El.Ed.).

OR

Higher Secondary (or its equivalent) with at least 50% of marks and 4-year B A/ B.Sc.Ed or B.A. Ed./B.Sc.Ed

OR

Graduation with at least 50 % marks and 1-year B.Ed(Special Education)

- (b) Pass in the Odisha Teacher Eligibility Test (OTET-Category-II)
- (c) Candidates must have Odia as MIL up to Class-X or pass in Odia language test equivalent to Matric standards conducted or declared equivalent by Board of Secondary Education, Odisha except the candidates as mentioned under Para.6.2.
