



AGREEMENT

This agreement is made on this 31st Dec 2018 between Chief Executive Officer, Zilla Parishad-cum-Collector, Balangir (hereinafter called as 1st Party of the one part) and....., Son / Daughter / wife of Sri aged about years, R/o. Vil..... (hereinafter called 2nd Party of the other part)

AND

Whereas the 2nd Party is willing to be engaged as Shiksha Sahayak to impart teaching in the Primary / Upper Primary School under School and Mass Education Department, Government of Odisha and to motivate the parents / guardians to send their children to school and will be assigned such other works relating to teaching for the objective of universalisation of primary education and implementation of Right of Child to Free and Compulsory Education Act, 2009.

AND

Whereas the 1st Party desires to engage the 2nd Party on contract basis as Shiksha Sahayak for the period specified hereunder and the 2nd Party agreed to enter into this contract and abide by the terms and conditions of this agreement.

NOW THIS AGREEMENT WITNESSED and the Party hereunder hereby agree as follows.

1. That the 1st Party shall provide engagement to the 2nd Party as SS in Primary / U.P. Schools for a period commencing on the date of agreement and valid for one year as agreed to by both the parties and the contract of this engagement if so facta shall be terminated on the last working day of the date specified for which no formal notice or order by Zilla Parishad, Balangir is required to be issued by the 1st Party. The contract will stand rescinded on expiry of the period.

2. That, the 2nd party shall submit himself / herself to the orders of Zilla Parishad and of the officers/ authority under whom he / she may from time to time be placed by the 1st party and shall at all time, obey the rules prescribed and shall discharge whenever required to perform such duties as may be assigned.

3. That, the 2nd party shall employ himself / herself efficiently and diligently and to the best of his / her ability.
4. That, the 2nd party shall be paid **Rs.7,400.00** (Rupees Seven thousand Four hundred) only per month as consolidated honorarium.
5. That, the 2nd party shall not claim the service benefit as admissible to the State Government employees.
6. That, the 2nd party shall not be eligible to get any other allowances and shall not claim any other dues except the honorarium as mentioned in clause (4) above.
7. That, the 2nd party shall not be eligible subject to exigency of public service for casual leave 12 days during an academic year.
8. That, the 2nd party shall not be entitled for any other kind of authorized absence beyond authorized leave, if she / he remains absent with permission and he / she does not have any authorized leave at his / her credit, proportionate amount from his / her consolidated remuneration shall be deducted.
9. That, teaching in the school shall be the main duty of the 2nd party (SS).
10. That, the 2nd party must ensure minimum level of learning (MLL) for the students as prescribed by the competent authority (SME Department).
11. That, the 2nd party must ensure at least 90% attendance of the children in respective school in all classes.
12. That, the 2nd party shall reduce the drop out of the children in school below 10%.
13. That, the 2nd party would attend training programme as may be fixed by the government from time to time.
14. That, the 2nd party shall abide by the rationalization of teachers policy of Government as issued from time to time.
15. That, the 2nd party has agreed to serve in the manner as required and perform the duties assigned by the 1st party and he / she has agreed to be disengaged without any notice on ground of involvement in criminal case / misconduct / delinquency / incapacitation / unauthorized absence/ poor performance.
16. The engagement shall be cancelled if any fraudulent testimonial is detected in future.
17. This engagement is subject to result of the W.A. 442/17 & other batch matters.

IT IS EXPRESSEDLY STATED AND AGREED that any duties rendered under the agreement by the 2nd party shall not in any circumstances whatever provide him/her any right to claim for any scale of pay or to be appointed in any service that may exist now or may arise in future in educational institutions or in any Government offices.
