

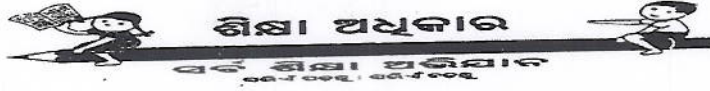


DETAIL INSTRUCTIONS FOR COUNSELING

The selected candidates whose names are placed in the 2nd round provisional/draft list only have to appear personally at **Office of the District Project Coordinator, RTE-SSA, Kandhamal, Phulbani at Main Road, Phulbani on 03.12.2018 at 10:00 AM onwards** positively for execution of necessary Agreement and Counselling for engagement to the Post of Sikshya Sahayak/Junior Teacher (Contractual) 2016. All the candidates have to bring with them all Original Certificates along with printed Agreement Paper (Non-Judicial Stamp Papers worth of Rs. 10/- Minimum) for execution of necessary Agreement with Collector-cum-CEO, Zilla Parishad, Kandhamal. The model Agreement is published with this notice for necessary reference.

All the selected candidates are also required to come with photocopy of all certificates/documents/testimonials along with printed copy of online application form, two nos. of Passport size photographs, identity proof, etc. No separate intimation shall be issued to individual candidates in this regard. The Vacancy will be filled up in order of merit; PH and Women candidates will be counselled first.

The Final Selection of PH Candidates (Selected under PH Reservation only) is subject to re-examination of the candidate by the Appellate Medical Board set up by the Govt. of Odisha at the SCB Medical College and Hospital, Cuttack before issue of engagement order. The selected Candidates, who have attended Counselling on dated **03.12.2018**, will receive their Engagement order from DPO, RTE-SSA, Kandhamal and join before DPC, RTE-SSA, Kandhamal on **10.12.2018**. They have to report at their respective schools within 5 days i.e. **15.12.2018** positively, failing which their selection and engagement order will stand automatically cancelled.

If any candidate is found to have submitted fake/forged certificates/ testimonials/ documents, her/his engagement as Sikshya Sahayak/Junior Teacher (Contractual) shall be cancelled with immediate effect. AGREEMENT

THIS AGREEMENT is made on this _____ day of _____ month of year 2018. Collector-cum-CEO, Zilla Parishad, Kandhamal (here-in-after called the 'First Party' of the one part AND Sri/ Smt/Kumari _____ S/O,D/O,W/O _____ aged about _____ years residing, At: _____, P.O _____, P.S _____, Block _____, Dist: _____) here-in-after called the 'Second Party' of the other part.

And whereas, the Second Party is willing to be engaged as **Junior Teacher (Contractual)** to impart teaching in the Primary/ Upper Primary Schools under School & Mass Education Department, Government of Odisha and whereas Govt. has only assigned the duty as per point no-9 in resolution No-25605/SME Dated 26.12.2016 of S& ME Deptt. Govt. Odisha

And whereas, the First Party desires to engage the Second Party on a contract basis as "**Junior Teacher (Contractual)**" for the period specified hereunder and the second party agreed to enter into this contract and abide by the terms and conditions of this agreement as per resolution No-25605/SME Dated 26.12.2016.

NOW THIS AGREEMENT WITNESSED and the parties hereunder agree as follows:

1. That, the First Party shall provide engagement to the Second Party as **Junior Teacher (Contractual)** in Primary/Upper Primary Schools for a period commencing on the date of agreement and shall remain valid for one year as agreed to by both the parties and the contract of this agreement ipso-facto shall be terminated on the last working day of the date specified for which no formal notice or order by the Zilla Parishad is required to be issued by the First Party. The contract will stand rescinded on expiry of the period of agreement.
2. That, the Second Party shall submit himself / herself to the orders of Zilla Parishad and of the Authorities under whom he/she may from time to time be placed by the first party and shall at all times, obey the rules prescribed and shall discharge duties as may be assigned from time to time.
3. That, the Second Party shall employ himself / herself efficiently and diligently and to the best of his/her ability.
4. That, the Second Party shall be paid consolidated monthly remuneration as decided by Govt. from time to time.
5. The Second Party shall not claim the service benefits as admissible to the State Govt. Employees.
6. That, the Second Party shall not be eligible to get any other allowances and shall not claim any other dues except the honorarium as mentioned in Clause -(4) above.
- 7 That, the Second Party shall be eligible for Casual Leave of 12 days during an academic year.

8. That, the Second Party shall not be entitled for any other kind of unauthorized absence beyond authorized leave. If he/she remains absent with permission and he/she does not have any authorized leave at his/her credit, the proportionate amount from his/her consolidated honorarium shall be deducted.
9. That, teaching in the school shall be the main duty of the second party, **Junior Teacher (Contractual)**
10. That, the Second Party must ensure minimum level of learning (MLL) for the students as prescribed by the competent Authority (S& ME Deptt.)
11. That, the Second party must ensure at least 90% attendance of the children in respective schools in all classes.
12. The second party shall ensure the zero drop out of the children in school.
13. The Second Party would attend training programme as may be fixed by Govt. from time to time,
14. The second Party shall be abide by the rationalization of teachers policy of Govt. as issued from time to time.
15. That, the Second Party has agreed to serve in the manner as required and perform the duties assigned by the First Party and he/she has agreed to be disengaged without any notice on ground of involvement in criminal case / misconduct / delinquency / incapacitation / unauthorized absence / poor performance/ misappropriation of Govt. funds.
16. That, the Second Party be assigned any other work in furtherance of the objective of universalization of Primary Education/RTE Act by the First party or any other authority as decided by Govt. in School & Mass Education Department from time to time.
17. The engagement shall be cancelled, if any fraudulent testimonial is detected in future.

IT IS EXPRESSLY STATED AND AGREED that any duties rendered under this agreement by the Second Party shall not under any circumstances whatsoever provide him/ her any right to claim for any scale of pay or to be appointed in any service that may exist now or may arise in future in any educational institutions or in any Govt. Offices.
