AGREEMENT JUNIOR TEACHER (CONTRACTUAL)

This AGREEMENT is made on this _____ day of _____ month _____ year Between Chief Executive Officer, Zilla Parishad-cum-Collector, Nabarangpur (herein-after called the 'First Party' of the One Part and Sri / Smt/ Kumari _____, Son/Daughter of Sri _____ aged about _____ years residing at _____) herein after called 'Second Party' of the other part.

And Whereas, the Second Party is willing to be engaged as **Junior Teacher (Contractual)** to impart teaching in the Primary / Upper Primary Schools under School & Mass Education Department, Government of Odisha and to motivate the Parent / Guardians to send their children to Schools and will be assigned such other works relating to teaching for the objective of universalization of Primary education and implementation of Right of Children to Free and Compulsory Education Act, 2009.

And whereas, the First Party desires to engage the Second Party on a contract basic as '**Junior Teacher (Contractual)**' for the period specified hereunder and the Second Party agreed to enter into this contract and abide by the terms and conditions of this agreement.

NOW THIS AGREEMENT WITNESSED and the parties hereunder, hereby agree as follows:

1. That, the First Party shall provide engagement to the Second Party in Primary / Upper Primary Schools for a period commencing on _____ day _____ month _____ year and ending on the _____ day _____ month _____ year, as agreed to by both the parties and the contract of this agreement ipso-facto shall be terminated on the last working day of the date specified for which no formal notice of order by the Zilla Parishad is required to be issued by the First Party. The contract will stand rescinded on expiry of the period.
2. That, the Second Party shall submit himself / herself to the order of Zilla Parishad and of the officers / authorities under whom he / she may from time to time be placed by the First Party and shall at all times, obey the rules prescribed and shall discharge whenever required to perform such duties as may be assigned.
3. That, the Second Party shall employ himself/ herself efficiently diligently and to the best of his /her ability.
4. That, the Second Party shall be paid Rs. _____ (Rupees _____) only per month as consolidated honorarium.
5. Teaching in the school shall be the main duty of the Junior Teacher (Contractual).
6. They must maintain regularity and punctuality in attending school.
7. They must ensure completion of entire curriculum within the specified time.
8. They must assess the learning ability of each child and accordingly supplement additional instructions if any as required.
9. They must ensure minimum level of learning (MLL) for the students as prescribed by the Competent Authority (School & Mass Education Department)
10. They must ensure at least 90% attendance of the children in respective schools in all classes.
11. They shall reduce the dropout of the children in school.
12. They shall motivate parents/guardians of the village in which Primary/Upper Primary School is situated for enrolment of children within the age group of 6 to 14 years. It shall be his/her duty to contact parents/guardians in case children fail to attend classes regularly and get back such children to the classes.
13. They will hold regular meeting with parents and guardians and appraise them about the regularity in attendance, ability to learn, progress made in learning and any relevant

information about the child.

14. They shall perform all such other duties as assigned to them by the competent authority as and when required.
15. They shall abide by the rationalization of teacher policy of Govt. as issued from time to time.
16. Whenever applicable they will work under the administrative control of Head Pandit/Head Master or Head Mistress in charge of the school to which he/she is assigned. They shall perform the duties as will be entrusted upon him/her by the concerned Head Pandit/Head Master or Head Mistress.
17. They may be assigned any other work in furtherance of the objective of universalization of Primary Education/RTE Act by the Chief Executive Officer, Zilla Parishad or any other authority as decided by Government in School & Mass Education Department from time to time.
18. The engagement shall be cancelled, if any fraudulent testimonial is detected in future of if he/she has been criminally proceeded against.
19. The Sikhsa Sahayak will get consolidated monthly remuneration as decided by the Govt. from time to time.
20. The Sikhsa Sahayak would attend training programme as may be fixed by Government from time to time.
21. The engagement would be on the basis of annual contract. In case Zilla Parishad decides not to renew the contract, appeal shall lie to the Govt. within three months of non-renewal of contract.
22. The Junior Teacher (Contractual) shall be eligible for casual leave of 12 days during one calendar year. She/he shall not be entitled to any other authorized absence beyond the above-mentioned period. If he/she remains absent with permission and if she/he does not have any authorized leave at her/his credit, the proportionate amount from consolidated remuneration shall be deducted.
23. Any Lady Junior Teacher (Contractual) who is having less than two surviving children is entitled to avail leave on account of maternity as decided by Government from time to time.
24. This engagement has been made as per the clarification from S&ME deptt. If any dispute arises in this regard (ORV) in any court of Law or Govt., he / she shall abide by the order of the authority. The engagement is subject to W.A. 442/17 (Banita Biswal-Vs-States & Others)

IT IS EXPRESSELY STATED AND AGREED that any duties rendered under this agreement by the Second Party shall not under any circumstances whatsoever provided him/her any right to claim for any scale of pay or to be appointed in any service that may exist now or may arise in future in any educational institutions or in any govt. offices.
