## PROCEEDINGS OF THE MEETING DATED 15.03.2018 REGARDING THE ISSUED RAISED BY OPEPA RELATING TO THE RESERVATION OF THE POSTS IN THE ENGAGEMENT PROCESS OF SIKSHYA SAHAYAKS

A meeting was conducted in the office chamber of Special Secretary, School & Mass Education Deptt. on 15.03.2018 at 11.30. AM on the above subject. The attendance of the meeting is annexed as Annexure-'A'.

After detail discussion, the following decisions were taken.

- 1. Candidates eligible by getting relaxation in age or percentage of marks in qualifying examination, are not eligible for UR. They are only eligible for their respective social category.
- 2. When sufficient women candidates are not available in 1<sup>st</sup> preference district, they will be picked from beyond 1st preference to satisfy women reservation quota in the respective categories.
- 3. The PH candidate of a social category can only fill up the post belonging to that social category.
- 4. Issue relating to submission of RCI registration certificate was raised by the Dy. Director(Admn.) on which it has been decided that as per Section-13(2) of the Rehabilitation Council of India Act, 1992, submission of RCI registration certificate is mandatory.
